

Sida waafaqsan Cinwaanka II ee Xeerka Maraykanka Naafada ah ee 1990 iyo Qaybta 504 ee Xeerka Daryeelka 1973, Gobolka Washington Waaxda Carruurta, Dhalin yarada, iyo Qoysaska (DCYF) uma takoori doonto si ku lid ah shakhsiyaadka u qalma naafooyinka ee qaabka naafada adeegyadeeda, barnaamijyada, ama hawlaha.

### **Wada xidhiidhka Waxtarka leh**

DCYF waxay, marka la codsado, bixin doontaa kaalmada iyo adeegyada habboon si loo xaqiijiyo wada xidhiidhka waxtarka leh ee dadka takhasuska leh ee naafada ah markaas waxay ka qayb geli karaan si loo siman yahay barnaamijka DCYF, adeegyada iyo hawlaha. Kaalmadan iyo adeegyada waxaa ka mid ah turjubaanada luqadda dhegoolaha, dhokumentiyada Indhoolaha loogu talo galay, iyo qaababka kale ee lagu heli kar macluumaadka iyo wada xidhiidhka dadka qaba liidashada hadalka, maqalka, ama araga.

### **Habbaynta ama Xeeradka iyo Nidaamyada**

DCYF waxay samayn doontaa habbayno macquul oo lagu sameeyo xeerarka iyo barnaamijyada si loo hubiyo in dadka naafada ah ay haystaan fursad loo siman yahay dhammaan barnaamijyada DCYF, adeegyada, iyo hawlaha.
