




- Do you have a contract with a language access organization? Find out the best way to book an interpreter.
- Schedule with an interpreters at least two weeks in advance
  - Simultaneous- interpretation at the same time you are speaking
  - Consecutive- you speak, they translate
  - Once scheduled, get the interpreters name and the email address they will be using to sign into zoom.
- Give your interpreter your meeting materials/agenda in advance
- Ask your interpreters and participant(s) that need interpretation to arrive 30 minutes early to set up and do sound check
- Speak slowly during the meeting



# of Meetings Since Last SICC held on February 16, 2022: 4 Meetings: February 22, 2022; March 14, 2022 (Special Budget Session); March 22, 2022; April 13, 2022 (Joint Meeting with SICC Public Policy Committee). The next scheduled meeting: May 11, 2022.

Topics Covered: The topics addressed across the four meetings include Initial Review ~ FFY 2022 IDEA Part C Federal Grant Application; IDEA Part C Grant Application and Section III Budgets; Impacts of Special Education (formerly School District) Billing Change (August 2021) Without a Corresponding Increase in Per Child Rates; Impact on ESIT Providers — Forecast/Budget for 2022; Joint Public Policy and Finance Committee Priorities [Protect ability for providers to bill private and public insurance for services; Increase and sustain federal and/or state funding with maximum amount passed through to direct services to offset reduction in family out of pocket revenue; Address and reconcile insurance requirements for collecting co-pays and deductibles including the False Claim Act]; Legislative Updates provided by Mary Sprute, GACE Public Policy Analyst; Fiscal Impact Survey Development and Dissemination; and Debriefing on Status of Special Conditions Proposed by President Biden's FFY 2023 Budget Proposal.

Committee Progress to Date: The committee successfully navigated the topics identified above and continues to benefit from strong member engagement across regular and special committee convenings. Agenda topics drafted for May's agenda include Review of the Systems of Payments and Fees Policy, Final Submission of FFY 2022 IDEA Part C Grant Application, Costs Associated with ESIT Over Three Initiative, and Preliminary Analysis of Fiscal Impact Survey Results.

Committee Challenges or Obstacles: The Finance Committee continues to jointly collaborate with the Public Policy Committee to address development and recommendations for an advocacy-based legislative decision package, with support from DCYF, to seek supplemental state funding in support of ending parent pay for receipt of services under Part C of IDEA. During the Special Budget Session held on March 14, 2022, parking lots topics were identified for future meetings and included the need for expanded public awareness activities, the need to support stability at the local service level, and increasing costs of technology.

Motion(s): <u>Special Budget Session held March 14, 2022</u>: A motion was moved and passed to allocate any increase in the FFY 2022 federal funds to the direct service provider contracts. One member abstained from voting.



# of Meetings Since Last SICC: 2 meetings since the last February SICC meeting Topics Covered: The Public Policy committee continues to collaborate with the Finance committee and advocacy groups of Wee Care and ECDAW. Meetings have been robust collaboration between the two committees with addition of the leads of Wee Care and ECDAW to partner with leadership of ESIT and committee members on how to address President Biden's FFY 2023 budget proposal and changes to Part C of IDEA. Particular discussion centers around the system of payments and fees that establishes no out-of-pocket costs to families for early intervention services. Here are key talking points.

- All members are in agreement that no out of pocket costs is right for families, but are seeking additional knowledge about potential fiscal impacts.
- -Concerns remain around rules to allow provider agencies to discontinue copays and deductibles while retaining the ability to bill third party payers (including False Claims Act) -Concerns regarding actual dollars lost and what impact this would have on provider agencies
- and services.
- The Fiscal Impact Survey has come to fruition as recommended by the Public Policy committee to support the discovery of actual dollars that my be lost through these impacts.
- -In collaboration with Wee Care and ECDAW, legislative priorities were reviewed with recommendations to continue to add to these legislative priorities as important talking points in the months to come.
- -Discussions are occurring regarding a potential proviso into the budget to ask for funding to recoup the loss in addition to some kind of policy piece of legislation to support the provider agencies to continue billing but not collect out of pocket fees from families.
- -Conversations about the new state incentive grant and what that will potentially mean.
- -Mary Sprute continues to keep the group abreast of legislative agendas and timelines. Committee Progress to Date: Development of legislative priorities for 2023 in partnership with Wee Care and ECDAW

Committee Challenges or Obstacles: None currently. All members are working collaboratively towards common goals.

Corrections for: Community Supports for Children and No Paid Services Caseload

Dear DDA Stakeholder,

The 2022 legislature convened on March 10, 2022 and submitted <u>Senate Bill</u> 5693 concerning the 2022 operating budget to Governor Jay Inslee for signature. Governor Inslee is expected to sign the budget by April 2, 2022.

This year's budget will create opportunities to reinvent our service delivery system in our state in many ways. DDA will be very busy in the coming months hiring staff and building capacity to implement what will be a robust and far reaching range of investments. In addition to what will likely be extraordinary growth and expansion of our service delivery system we are also hopeful that this year will put the COVID pandemic era behind us. Look for more on these efforts in the coming months.

I am delighted to share the budget's highlights for DDA below:

- Concurrent Services Funding is provided to implement Substitute
  House Bill 1980 (concurrent services), which removes the prohibition on
  eligible DDA clients access employment services and community
  inclusion services concurrently. (\$13.6M total funds; \$8.4M GF-State;
  1.0 FTE)
- Community Supports for Children Funding is provided to expand Intensive Habilitation Services (IHS) and Enhanced Out-of-Home Services (E-OHS) options for children and youth aged eight to 21 who are DDA clients. Two, three-bed facilities will be phased in to provide short-term (up to 90 days) IHS placements for children and youth aged eight to 21. An additional six three-bed facilities will be phased in for long-term E-OHS so support youth aged 12 to 21 who have discharged from inpatient care. (\$2.3M total funds; \$1.3M GF-State; 2.9 FTE)
- Enhanced Case Management Program Funding is provided to expand access to the Enhanced Case Management Program (ECMP)

from 700 to 1,500 clients in FY 2023. A total of 50.0 FTEs are phased in and are assumed to be fully in place by the fourth quarter of FY 2023, including case managers, nursing consultants, and supporting staff. Funding is also provided to create an automatic nursing referrals system for ECMP clients in the Comprehensive Assessment Reporting and Evaluation system. (\$4.0M total funds; \$2.0 GF-State; 15.7 FTE)

- Transitional Care Management Funding is provided to phase in a total of 35 FTEs through June 2023 to create transition coordination teams to coordinate transitions of care for clients who move from one type of care setting to a new one. The Department shall submit a preliminary report in December 2022. The Legislature intends that an annual report be submitted thereafter that describes the outcomes associated with client transitions before and after implementation of these transition coordination teams; a description of lessons learned since the teams were implemented, including an identification of what processes were improved to reduce the timelines for completion; and recommendations for necessary changes to improve stability of client placements. (\$3.8M total funds; \$2.2M GF-State; 14.1 FTE)
- Financial Eligibility Staff and Reporting One-time funding is provided to improve the timeliness and accuracy of eligibility reviews, application processing, case maintenance, and updates for DDA clients. This funding will improve DDA's ability to meet the 45-day application process requirement specified in WAC 183-503-0060. (\$2.5M total funds; \$1.4M GF-State; 11.2 FTE)
- Enhanced Community Residential Rate Funding is provided to increase rates for contracted Supported Living and other community residential service providers effective July 1, 2022, with the intent of providing hourly wage increases for employees of community residential services contractors providing direct care to DDA clients. The rate increase equates to a 23 percent increase in the instruction and support services portion of the rate. (\$154.5M total funds; \$77.3M GF-State)
- Targeted Provider Rates Funding is provided to continue the COVID

   19 rate enhancements for contracted providers. The temporary rate
   add-ons in effect in December 2021 will continue through June 2022
   and then will be adjusted to reflect base rate increases funded in the
   2021-23 biennial budget before being phased out by June 2024 by
   reducing them 20 percent every two quarters. (\$151.4M total funds;
   \$72.0M GF-State)
- DDA No-Paid Caseload Substitute Senate Bill 5819 requires the
  Department to hire two, permanent FTEs to regularly review and
  maintain the no-paid services caseload and to provide case
  management services to individuals on the no-paid services caseload at
  a ratio of one case manager for every 300 clients to contact and
  respond to clients to discuss their needs and explain service options

available through the Department or other community resources. (\$4.6M total funds; \$2.6M GF-State; 18.8 FTE)

Thank you to everyone who contributed to the incredible volume of requests associated with legislative session this year. The senate and house representatives truly recognized the needs of the people we support this year, effectively passing bills that will make a real difference in the lives of the people we support. The budget the Governor ultimately signs off on is sure to be a tall order for all of us. So, please be prepared to roll up your sleeves; it's going to take an ambitious and collaborative effort to execute the legislative package this year. Stay tuned for more.

### Health Care Authority Updates

**SICC Meeting April 2022** 

#### 2022-23 supplemental budget approved items

#### **ABCD** outreach

Funding is provided to the Authority to contract with the Office of Equity to provide equity training for the local Access to Baby Child Dentistry (ABCD) coordinators.

#### **Behavioral health provider rates**

Funds are provided for a 4.5 percent increase in Medicaid reimbursement for community behavioral health providers contracted through managed care organizations, effective January 2023.

#### **Child assessment and diagnosis**

These funds will increase provider training to teach them to use the current version of the diagnostic classification: 0-5 classification system of mental health and developmental disorders of infancy and early childhood as established in Section 2(11), Chapter 126, Laws of 2021.

#### **Continuous enrollment**

Funding is provided to implement continuous enrollment for Medicaid-eligible children ages zero to six with income at or below 215% of the federal poverty level upon receipt of a 1115 waiver approval from the Centers for Medicare and Medicaid Services.

#### **Periodic screening**

This funding will update the well child visit periodicity schedule for Apple Health clients to align with Bright Futures recommendations for ages <1 to 20.

#### **SBHS** funding

Funding is provided to support school-based health services by removing the financial contribution requirement for school districts.

#### **Continuum of care**

Children and youth with complex behavioral issues need a continuum of care across state agencies and local providers. Funding is provided in the outlook for rates for 32 beds and agency administration at the Health Care Authority to create a short-term Residential Crisis Stabilization Program (RCSP) for youth with severe behavioral health diagnoses.

#### Children's dental rate increase

Funds are provided to increase child dental rates to equal respective adult dental rates.

#### Children's long-term inpatient program

Funds are provided to expand the availability and access of long-term inpatient beds in contracted settings for children requiring intensive supports statewide through the Children Long-term Inpatient Program (CLIP).

#### Prenatal to 25 BH facilitation

This funding will help facilitate the Children and Youth Behavioral Health Workgroup to develop a strategic plan for the delivery of behavioral health services for prenatal to age 25.

#### **Wraparound with intensive services**

Pursuant to the settlement agreement under AGC v. Washington State Health Care Authority, funding is provided to expand eligibility for Wraparound with Intensive Service (WISe) to undocumented immigrant and refugee children ineligible for federally funded Medicaid benefits.

#### **Interpreting and language access services**

HCA's interpreter services team and Universal Language Service has signed a new spoken language contract to provide over the phone and video remote interpreting services.

The contract will go live this spring and will assist Apple Health Medicaid providers in meeting their <u>Title VI of the Civil Rights</u> <u>Act of 1964</u> responsibility. The new services will increase health equity for Apple Health providers, language access providers, and Apple Health clients.

#### Infant-early childhood mental health team

The Infant-Early Childhood Mental Health team at HCA is working on implementation of the Mental Health Assessments for Young Children program. This is a program specifically for Apple Health/Medicaid mental health providers who are serving children under age six enrolled in Apple Health/Medicaid. The program allows for enhanced reimbursement to support developmentally appropriate mental health assessment (i.e. mental health intake evaluation; diagnostic evaluation; diagnostic assessment) for young children, including allowing providers to bill for up to 5 assessment sessions and get reimbursement for travel costs when conducting assessments in home or community settings. The program also works to support providers in using the DC:0-5 as the diagnostic manual for theses assessments, including by providing free training in the DC:0-5 and offering a Medicaid-specific crosswalk for connecting DC:0-5 diagnoses to DSM diagnoses and ICD-10 codes.
