

# Dept of Children, Youth, & Families 2025-27 Regular Budget Session Maintenance Level - C1 - FFPSA Backfill

### Agency Recommendation Summary

The Department of Children, Youth, and Families (DCYF) requests the federal authority for the Family First Prevention Services Act (FFPSA) grant assumed in the budget be backfilled with General Fund – State (GF-S) in the amount of \$22,850,000 with a corresponding General Fund – Federal (GF-F) reduction in the amount of \$22,850,000 in the 2025-27 Biennial Budget. This funding swap is requested because the federal reimbursement through the FFPSA will not be available until the Comprehensive Child Welfare Information System (CCWIS) system is implemented.

#### **Program Recommendation Summary**

### **Decision Package Description**

The Family First Prevention Services Act (FFPSA) was signed into law on February 9, 2018. FFPSA allows for federal Title IV-E reimbursement for prevention services under the state's Family First Prevention Plan, which was approved by the federal government in October 2020.

The enacted 2019-21 and 2021-23 biennial budgets appropriated federal authority with a corresponding reduction in general-fund state funding, under the assumption DCYF would begin claiming federal FFPSA. However, to claim FFPSA, service level information is required for submission to the federal government, which DCYF's current child welfare case management system, FamLink, does not contain. In addition, the FamLink system does not comply with the U.S. Department of Health and Human Services' (HHS) Office of the Administration for Children & Families (ACF) Final Rule on Comprehensive Child Welfare Information System (CCWIS); therefore, the agency is unable to achieve the federal funding previously anticipated in the budget. A Comprehensive Child Welfare Information System (CCWIS) is a case management information system that state and tribal title IV-E agencies may develop to support their child welfare program needs. If a title IV-E agency elects to build a CCWIS, the federal government will provide a more favorable reimbursement than is provided for non-CCWIS systems if the system meets federal requirements. DCYF is currently in the process of developing a CCWIS, which is projected to be completed by June 30, 2029. Once the CCWIS is implemented, DCYF will then be able to claim FFPSA.

With suppressed spending the pandemic and social worker vacancies, the state reduction was manageable within DCYF's budget. However, with the passage of the Keeping Families Together Act (HB1227), DCYF is experiencing an increase in prevention services. In addition, DCYF has been able to fill social worker positions, leaving no room in DCYF's budget to absorb the general fund-state transferable reduction. Therefore, DCYF requests the backfill of FFPSA funding until the agency is able to claim FFPSA.
