# CPA Contract Rates Update

- DCYF will move forward with hold harmless.
  - Reimbursements to providers are expected to be higher in the new structure than under the old rate structure of \$481.
  - If providers do end up with a lower overall payment, DCYF will pay the difference for the hold harmless period.
- DCYF will research and model CPA costs related to:
  - a. Licensing
  - b. Placement coordination.
  - c. Any other areas that we determine are required of CPAs under the Licensing WAC
- DCYF will need time to seek funding for any increases related to the above items.

## CPA Contract SOW

- Changes made based on feedback from 8/15 meeting.
- Timelines for incorporating feedback received yesterday.
- Collect additional feedback
  - What WAC or RCW do CPA providers feel are in conflict with the draft contract?
    - DCYF has initially identified some potential areas.
