Step 1 – Transferring to a CPA with a Placement in the Home

This process is used when there is a child or youth placed in the Kinship Home.

Note: If a family has an Initial License and is getting fully licensed through a CPA, the CPA must complete the license within 90 days of receiving the Initial License. If not done within 90 days, there will be a break in payment, the Initial License will close, and payment will restart once fully licensed.

Kinship Notification Unit Specialist (KNU)	<ol style="list-style-type: none">Intake family in WA CAP on the Kinship License track. Note: Once the intake is complete, WA CAP will automatically send a welcome email to applicant containing a link to log in.If CPA is not yet identified,<ol style="list-style-type: none">Collect and review the completed “Home Study or Reassessment Application (DCYF 10-354)”.Apply the Multi-License Tag in WA CAP, as applicable.Verify the Initial License Tag was applied previously if the applicant(s) received an initial license.Engage with applicant to complete identified forms and supporting documents. Note: An application and background checks may have been completed when working with the KNU Specialist. Tags may have been applied.
Applicant	<ol style="list-style-type: none">Contact private agency to communicated desire to be licensed with them.
Private Agency Licensor	<ol style="list-style-type: none">Ask applicant the following questions:<ol style="list-style-type: none">Has background paperwork been completed for anyone online?Has anyone received fingerprint instructions but not completed them yet?Have fingerprints been completed for anyone in the home and on the property when working with the KNU/KCEU Unit?Notify Regional Licensor to communicate family’s decision to become licensed with a CPA.

Private Agency Supervisor	<ul style="list-style-type: none"> 16. Assign applicant(s) to Parent Agency Worker <ul style="list-style-type: none"> a. Click “Edit Application”. b. Change “Parent Agency Worker” (up to six). c. Private Agency Licensor Supervisor is automatically assigned. d. Click Update Application at the bottom of this page to save the changes.
Private Agency Licensor	<ul style="list-style-type: none"> 17. Select the “Waive” option for all documents not required for the applicant or agency as outlined in the Required Documents for Child Placing Agency – Kinship License section. <ul style="list-style-type: none"> a. When waived, it shows applicant a green check mark and communicates it is not necessary for the type of license they are getting. 18. Contact applicant(s) to start the licensing process. <ul style="list-style-type: none"> a. Ask applicant to complete/update their application. b. Ask applicant to complete the background checks steps for any applicant/household members/person on property who have not been cleared. c. If your agency chose to have a passcode option, provide passcode “cpa4kinship” to use at the appropriate stage (may be called Orientation, Next Steps, etc).

For people who have cleared background checks:</p> <ol style="list-style-type: none"> Enter N/A or Already Completed for the Online Confirmation number. Background checks will be transferred. <p>21. For people who have not received a cleared background check:</p> <ol style="list-style-type: none"> Applicant(s) will receive an automated email. A link will be provided to begin working on the application documents. Complete Authorization and Consent to Share Records (CPA Home) (DCYF 15-824A) Fill out Background Confirmation and Out of State Check (DCYF 15-460) and ensure background forms have been completed for applicant(s), all household members, and others living on the property. <p>Note: Applicant(s) will click on "Background Check Central Unit (BCCU) link to complete their online background authorization form. Then applicant(s) will enter confirmation code in WA CAP on the Background Confirmation and Out of State Check form. Each applicant/household member/others living on the property will do this and enter their confirmation code on their form.</p> <ol style="list-style-type: none"> Upload valid government ID.

Step 1 – Transferring to CPA with No Placement in the Home

This process outlines when Child Welfare is referring for a Kinship Home Study when a child or youth is not already placed in their home.

Note: If a family has an Initial License and is getting fully licensed through a CPA, the CPA must complete the license within 90 days of receiving the Initial License. If not done within 90 days, there will be a break in payment, the Initial License will close, and payment will restart once fully licensed.

Kinship Notification Unit Specialist (KNU)	<p>23. Receive assignment from KNU Supervisor.</p> <p>24. Contact and Intake family in WA CAP on the Kinship License Track.</p> <p>25. Initiate background checks for all household members identified at Intake.</p> <p>26. Notify KNU Supervisor that potential kinship applicant is ready to transfer to CPA.</p> <p>27. If CPA is not yet identified,</p> <ol style="list-style-type: none"> Collect and review the completed “Home Study or Reassessment Application (DCYF 10-354)”. Apply the Multi-License Tag in WA CAP, as applicable. Verify the Initial License Tag was applied previously if the applicant(s) received an initial license. <p>28. Engage with applicant to complete identified forms and supporting documents.</p>

Step 2: Applying

This step outlines the process for when the status of an applicant is moved from the “Recruiting” phase of WA CAP to the “Applying” phase.

Step 3: Approval

The approval phase is how to now review and approve a license. The approval assessment process has not changed from current practice. The only change is the system functionality of approving a license.

Step 4: Withdraw When No Application Has Been Submitted

This process is to be used when the private agency has intake a family into WA CAP but an application has not been submitted.

Private Agency Licensor	<ol style="list-style-type: none"> 1. Determine if agency is no longer working with the applicant. 2. Update status from “Recruiting” to “Recruiting Dropout/No Application Started”. <ol style="list-style-type: none"> a. Click on the “Change Application Status” tab. b. Select “Recruiting Dropout/No Application Started”. c. Select the reason that best applies to the specific circumstance. d. Provide a brief explanation in the explanation box. e. Select “Update Status”. 3. Go to Edit Application, remove Partner Agency Worker.

Step 4: Withdraw

This process is to be used when the private agency has decided to withdraw an application.

Private Agency Licensor	82. Determine if application needs to be withdrawn. 83. Notify Regional Licensor of a withdraw and include the reason and the effective date.
Regional Licensor	84. Update status from “Applying” to “Withdrawn/Closed Preapproval”.

Step 4: Submit to Regional Licensing then Withdraw

This process is to be used when the private agency has filled out the home study and has submitted it to Regional Licensing for review but then decided to withdraw the application.

Select appropriate outcome in the “Home Study Information” section of the Home Study. <ol style="list-style-type: none"> a. Select “Not approved, application withdrawn” 6. Save Home Study (DCYF 10-043) as PDF or print the home study. 7. Sign home study. 8. Send signed home study to private agency supervisor for them to sign. 9. Upload signed home study in the “Supporting Documents” section in the “Documents” tab in WA CAP. <ol style="list-style-type: none"> a. Select “Withdrawn Home Study (Worker Upload Only)” 10. Notify Regional Licensors of a withdraw including an explanation of why and the effective date. 11. Include if the family has a home study uploaded in WA CAP.

Step 5: Denial

This is the process for a legal licensing denial. This process should only be followed when there is legal sufficiency to deny the application.

Communicate denial decision with Private Agency Licensors, Private Agency Supervisor, and Regional Licensors Supervisor. 5. Follow existing LD denial policy and procedure. 6. Remove partner agency.
