## FFY 18 DETERMINATIONS

The Individuals with Disabilities Education Act (IDEA) requires the U.S. Department of Education to make annual “determinations” regarding the overall compliance of each state with the requirements of IDEA Part C. States are likewise required to make “determinations” regarding the level of overall compliance each year for each Local Lead Agency (LLA) in the state. As the state lead agency for IDEA Part C, the Department of Children, Youth, and Families Early Support for Infants and Toddlers (ESIT) program notified LLAs in writing of their 2018-19 determination level on Jan. 6, 2020.

The notifications issued on Jan. 6, 2020, summarized LLA performance on implementation of IDEA Part C for the time period of July 1, 2018, through June 30, 2019. ESIT is making this information available to the public pursuant to Part C regulations. IDEA details four categories for both the state and LLA determinations. The levels of determination may be:

- Meets the requirements of IDEA;
- Needs assistance in implementing the requirements of IDEA;
- Needs intervention in implementing the requirements of IDEA; or
- Needs substantial intervention in implementing the requirements of IDEA.

IDEA identifies specific technical assistance and/or enforcement actions that the state must take, under specific circumstances, for LLAs that are not determined to “meet requirements.” Additional information about the annual determinations can be found on the [DCYF Reports webpage](#).

The following tables reflect each LLA’s performance in meeting the requirements of Part C of IDEA, which serves infants and toddlers with developmental delays ages birth through two, for FFY18.
