¿Jas uwach ri jun usolik uxe' kab'anik rech CPS?

Jun usolik uxe' kab'anik rech CPS are' jun utzalixik uwach jun uya'ik uch'a'ik che jun ak'al b'anom k'ax chech on ya'om kanoq. Are jun b'anoj cholajim xuquje' sib'alaj utz ka'ilik we b'anom k'ax, man utz ta rilik b'anom on ya'om kan jun ak'al, pacha' o we wa' kuya ri ak'alab' pa jun k'ax on man utz ta kilik kab'an aq'an pa jun q'iij, xuquje' we ri ak'alab' utz e k'o wi. Wa' katz'aqatisax ruk' usolik uxe' xuquje' uta'ik kitzij nik'aj chi winaq.

¿Jas che katajin kab'an jun usolik uxe' chi wech?

- Le Department of Children, Youth & Families (Wokaj kech Ak'alab', K'ajolab' & aj Upaja, DCYF) xya jun q'alajisanem ruk' taq mayowem chi rij kichajixik ri awalk'u'al.
- Le q'alajisanem utz'aqatisam le uya'ik ub'iixik chi uwach q'at'b'altzij rech ri ub'anik k'ax xuquje' ri man utz ta rilik jun ak'al (RCW 26.44.020).
- Le q'alajisanem xuk'utu che tzij k'o jun nimalaj k'axk'olil aninaq chech le awalk'u'al.
- DCYF karaj kachakun awuk' are che qas utz kichajixik ri ak'alab' kab'anik.

¿Jas ri kel kub'ij ri Ub'anik k'ax xuquje' ri man Utz ta kilik ri A'alab'?

Ub'anik k'ax o n man ka'il ta ri ak'al are kub'ij q'ajq'ob'em, ub'anik k'ax chech ri ch'akul on reqelexexik uch'akul jun ak'al rumal jun chi winaq jawije' ri u'utzwachil ri ak'al, ub'antajik xuquje' uchajixik sib'alaj b'anom k'ax che, o ri rilik kab'anik o xa kab'an k'ax che ri ak'al. ¿Jas keye'x chech we usolik uxe' kab'anik?

- DCYF kuya uq'iij le junamil kech ri aj upaja xuquje' kechakunik are chi qas kkilo che utzalaj ja kek'oj' wi ri ak'alab' we qas utz kek'oj' chla' maj l'ax kkiriqo. Le chajinem rech le ak'al sib'alaj rajawaxik xa k'u cha' le ka'ilow le kaso kachakun awuk' chech uriqik jun jun utzalaj k'olibal chech le ak'al, we rajawaxik.
- At chi'l le awalk'u'al rajawaxik utz iwilik kab'anik xuquje' kixch'ab'ejik ruk' k'ixbalil.
- Pacha' tat, chajinel chi uwach le q'at'b'altzij o jun chi winaq kata atzij rumal rajawaxik pa le usolik uxe' kab'anik.
- Chi uwach ri taqanik, ri ak'alab' utz kata kitzij xuquje' kelesax kiwachib'al, pacha' utz'aqatil le usolik uxe' kab'anik, man ruk' ta aya'b'al b'e. Ri ak'alab' ya'tal chi kech che utz kakicha jun chi winaq are che kak'oj'ik are taq kata kitzij.
- Le usaqil tzij katzukuxik are taq kariqitaj jatsaq tz'ib'atalik xuquje' ri uta'ik taq tzij kuk' nik'aj chi winaq sib'alaj rajawaxik.
- Are taq we k'o jun unimal makaj b'anom, le ajsolol uxe' rech CPS utz ke'utzukuj nik'aj chi ajchakib' chech umulixik usaqil tzij che man xaq ta kakamulixik.
- Utz kaya taq pataninem chech rilik uchomaxik taq le rajawaxik chech le aj upaja, unitz'arisaxik le k'axk'ol chi'l taq le mayowem rech chajinik, o pa le awech at wene kataq b'l pa taq le Family Voluntary Services (Pataninem kech Winaq man ketoj taj rech le aj Upaja, FVS) chech rilik.

¿Jas uwach taq ri kariqitajik?

Ri taq uya'ik uch'a'ik wene' are' "Kach'ob' rij" o "Man kach'ob' ta rij". Jun riqitajem Kach'ob' rij are kel kub'ij che, are tzij le usaqil tzij k'olik, wene tzij wi b'anom jun k'ax on man utz ta kilik ri ak'alab' b'anom chi uwach che man tzij taj. Ri Man kach'ob' ta rij are kel kub'ij che, are tzij ri usaqil tzij k'olik, wene man tzij taj b'anom ri ub'anik k'ax o man utz ta kilik ri ak'alab' b'anom o maj qas usaqil tzij chech rilik we tzij xk'ulmatajik o no'.

¿Jas kab'an che uya'ik ub'iixik le riqitajinaq?

Kataq jun wuj cheh uya'ik ub'iixik chi awech ri riqom. We le usolik uwach kach'ob'otajik, pa le tz'ib' wuj kab'ix wi chi awech jas kab'an chech uya'ik uch'a'ik ri riqom. We uya'ik uch'a'ik rajawaxik ke'open p ale ja chakub'al rech DCYF pa jun uq'ijol rech 30 q'iij are taq k'amom chi le tz'ib' wuj rech ri riqom o are taq qas kaya uchomaxik le riqom. Qas chawila' che, we katqax pa jun chik ja, le ka'ilow taq le kasos qas kareta'maj le k'ak' awachochib'al.

¿Jawije' kub'an wi k'ax chi wech jun riqitajem utz kachomax rij?

Le riqitajem kach'ob' rij kowax uk'olik pa le wokchakub'al rech taq le kematz'ib' rech DCYF. Wene kakoj chech nik'aj chi jastaq:

- Uchomaxik we utz katoj ajchak, tob'anel on jun winaq man katoj taj chech kichajixik taq ak'alab' chi'l nimaq winaq maj kikowinem.
- K'ulmatajinaq kanoq, wene kab'an na nik'aj chi uch'a'ik.
- Uchomaxik we at utz katcha' chech uya'ik jun ak'al jun chi achalaxik k'o che uchajixik awuk'.
